- It is mandatory for all applicants to pay registration fees.
- Once the applicant's has been registered, the Swapnil Group will provide a franchiser code to the franchiser, which the franchiser can use for lifetime.
- The franchisor code can be used only and only by the franchiser.
- If the franchiser code of franchiser's is used by someone else, the franchiser code of that franchiser will be revoked by the Swapnil Group Committee or the founder of the Swapnil Group, in which case the franchiser will cannot use their franchiser code in future.
- It is necessary for the franchiser to deposit an inheritance amount of Rs 50,000 / -.
- The franchiser must have his own space or rent 10 X 15 space.

09. It is required by the franchiser to submit the permanent leaf documents (with photos) to the Swapnil Group itself or to the rental space.
10. It is necessary for the franchiser to arrange the entire furniture in his office such as chair, table etc.
